6 **Time:** Pursuant to CRIT Property Code § 1-306, you shall appear and defend
7 within ten (10) calendar days after completed service of this summons upon
8 you, exclusive of the day of service.

10 clerk of this court within the time stated above, accompanied with the
11 necessary filing fee, if any, **and** serve a copy of your written answer or
12 response upon the plaintiff or plaintiff's attorney, if any, whose addresses
13 are stated below on this summons.

14 **Warning:** If you fail to appear and defend in the time and manner directed in this
15 summons, the relief requested in the complaint or petition will be granted
16 and judgment against you by default will be entered.
